CHECK LIST FOR THE 2022-2023 SAFE ENVIRONMENT AUDIT YEAR



- Every adult who works with minors has a current background check. (We re-check everyone who is still active every 5 years.)
- _____ Every adult who works with minors has attended the initial 3-hr. VIRTUS live session.
- Every adult who works with minors is up-to-date with his/her required ongoing-training (monthly VIRTUS bulletins -- and -- the <u>Keeping the Promise Alive 3.0</u> re-certification video module, <u>if</u> it has been assigned to him/her).
- _____ Dates of upcoming VIRTUS sessions are provided to our new employees and volunteers.
 - ____ The <u>Promise to Protect Pledge to Heal</u> poster is located in an area that can be easily seen by employees and volunteers and anyone entering our church/mission/school.
- The *flyer*, "How To Report Sexual Abuse of a Minor by a Cleric or Church Worker/Volunteer of the Diocese of Alexandria" that includes *contact information for reporting sexual abuse*, is located in an area that can be seen; and, additional copies are easily accessible to everyone entering our church/mission/school.
 - _____ Since July 2022, an announcement/statement has been made/will be made (at least twice during the current audit year) that this *flyer* is available for those who wish to take one.
- _____ Since July 2022, an announcement/statement has been made/will be made (at least twice during the audit year) that the <u>Diocesan Policy for the Protection of Minors</u> can be accessed under *Safe Environment* on the diocesan website: <u>www.diocesealex.org</u>; and, that a hard copy may be requested from the Safe Environment Office.
- _____ Since July 2022, an announcement has been made that the diocesan *Code of Pastoral Conduct for Priests, Deacons, Pastoral Ministers, Administrators, Staff, and Volunteers* can be accessed under *the* <u>Safe Environment</u> section of the diocesan website: <u>www.diocesealex.org</u>; and, that a hard copy may be requested from the Safe Environment Office.
- An announcement/statement has been made -- *at least quarterly* -- reminding employees and volunteers to check their online VIRTUS account to ensure they are current with required ongoing-training items (bulletins and/or *re-certification video module*). [Assistance is available from the safe environment office, if needed.]

CHILDRENS TRAINING Requirements for 2022-2023

- Our children/youth have participated/will participate this audit year (2022-2023) in the VIRTUS Empowering God's Children (EGC) training program. [This is mandated by the Charter for the Protection of Children & Young People.]
 Lessons 1 & 2 have been/will be taught before February 15, 2023.
- An Opt Out Form has been/will be provided to parents/guardians so that they are given an opportunity to "opt out" their child/ren's attendance when the lessons are taught.
 Any Opt Out Form that is returned to us has been placed in our 2022-2023 safe environment files.
- _____ If a child is/was not present for the lessons (for whatever reason, i.e., *opted out*, ill, etc.), a hard copy (of the lessons plans) has been/will be offered to the parents/guardians so that they may teach their child/ren the information at home. A record of this offer and, whether the offer was accepted/rejected -- has been recorded in our 2022-2023 safe environment files.
- A roster/list of our CCD teachers (include "subs" & temps) is on file; and this roster/list indicates whether or not each of them are safe environment compliant.
- A roster/list of our children/youth is on file; and this roster/list indicates whether or not each child was "opted out/trained/absent" for Lessons 1 & 2.
- _____The *EGC Reporting Form*, which indicates the data for those who were "opted out/trained/absent", has been forwarded to the Safe Environment Office; and, a copy is in our files.
